ORDINANCE RELATING TO THE USE OF THE LEMPSTER TRANSFER
STATION / RECYCLING CENTER ORDINANCE # L-1990-01

THIS REPLACES ORDINANCE # L-1976-01 DATED APRIL 19, 1976

PER ORDER OF THE SELECTMAN OF THE TOWN OF LEMPSTER , As of January 1, 1990 all residents, taxpayers, and holders of special permits who are entitled to the use and privileges of the Lempster Transfer Station / Recycling Center, shall hereby abide to the following rules and regulations governing the use of said Transfer Station / Recycling Center.

1. The Lempster Transfer Station / Recycling Center will be open to all authorized users two (2) days a week. There will be a summer schedule and a winter schedule. The days and hours of operation are subject to change as the needs of the town change. These days and hours of operation will be posted in two (2) public places. 1. At the main entrance to the Lempster Transfer Station / Recycling Center located on Lovejoy Road in Lempster. 2. At the main entrance to the Lempster Town Office Building located on Route 10 in East Lempster.
2. Disposing of refuse or recyclable items shall be carried out under the supervision and direction of the town of Lempster Transfer Station / Recycling Center attendant.
3. Disposing of refuse or recyclable items must take place during the specified hours of operation and on the specified days. There will absolutely be no disposing of refuse or recyclable items at any time other than the specified posted days and hours of operation , unless written approval by the selectman for the town of Lempster has been obtained.
4. At no time shall anyone dispose of refuse or recyclable items onto the Town of Lempster Transfer Station / Recycling Center property by disposing of said refuse or recyclable items over the fence adjacent to the Town of Lempster Transfer Station / Recycling Center.
5. All authorized users of the Lempster Transfer Station / Recycling Center are required to have a valid permit decal visible on their vehicle. Decals will be available at the Lempster Town Office Building located on Route 10 in East Lempster, and will be issued to all taxpayers and residents of the town of Lempster upon proof of

NOTE:

6. Authorized users of the Lempster Transfer Station / Recycling Center must dispose of refuse or recyclable items from the Town of Lempster only. Refuse or recyclable items brought in from another town will not be accepted without special written permission from the selectman for the Town of Lempster.

7. No material may be removed from the Transfer Station / Recycling Center without the express permission of the Lempster Transfer Station / Recycling Center attendant or from the selectman for the Town of Lempster.

8. The Lempster Transfer Station / Recycling Center personnel will report any violation of this ordinance to the Police Department.

9. ANY VIOLATION OF THIS ORDINANCE WILL BE SUBJECT TO A FINE OF NOT MORE THAN \$ 100.00.
