

**TOWN OF LEMPSTER, NEW HAMPSHIRE**

**Enactment of Town Ordinance.**

Let it be known that on the 22nd day of Dec. 2004 the Board of Selectmen of the Town of Lempster, New Hampshire enacted the following ordinance:

**Section 1 Weight Limit on Crescent Lake Road**

No vehicle having a gross vehicle weight of Twelve Thousand (12,000) pounds or more as listed on the vehicle registration shall be driven on Crescent Lake Road between the intersection of 2<sup>nd</sup> New Hampshire Turnpike and the Acworth Town Line, except for the purposes of making deliveries to, providing services for, or going to or from a specific place.


The provisions above shall not apply if the person or corporation obtains a Permit to Exceed Weight Limit from the Highway Supervisor or the Board of Selectmen. The permit must be shown upon the request of any police officer and must be in each vehicle permitted to exceed the weight limit.

The Highway Supervisor or Board of Selectmen may require a bond or other such surety against road damage be posted by the person or corporation prior to issuing any permit to exceed the weight limit.

The permit may be revoked by the Highway Supervisor or the Board of Selectmen for any violation of the conditions of the permit.

**Section 2 Penalties**

Any person or corporation found in violation of this ordinance shall be guilty of a violation and be fined not more than One Thousand (\$1,000).

Weight Limit Ordinance for Lovejoy Road  
A Class V Highway

Lovejoy Road from State Highway Ten to the intersection of Second New Hampshire Turnpike on Lempster Street shall be posted for a maximum weight limit of 18,000 pounds (9 tons) and to no through trucking. Signs shall be placed at both ends of this road.

Exceptions shall be emergency vehicles and those covered under R.S.A. 236:3-a and any vehicle deemed to be used for the benefit of the Town.

This ordinance will prevent unreasonable damage and safety issues on this narrow road.


Maximum Weight Limits can be established by the local governing body (Selectmen) under R.S.A. 231:191, I-VII. Fines and Penalties under R.S.A. 266:25.

The provisions above shall not apply if the person or corporation obtains a Permit to Exceed Weight Limit from the Highway Supervisor or the Board of Selectmen. The permit must be shown upon the request of any police officer and must be in each vehicle permitted to exceed the weight limit.


