### **Agenda Item 4: New Business**

Acceptance and Expenditure of the following: Avangrid donation for the Library \$2,995 50/50 Grant for Forest Fire equipment \$2,000

Mr. Beard explained the upgrades to the technology at the Library which will be purchased with the donation. electman Thurber made a motion to accept and expend the \$2,995 from Avangrid. Selectman Grenier seconded the motion. All were in favor.

Selectman Thurber made a motion to accept and expend the \$2,000 grant for the purchase for Forest Fire equipment. Selectman Grenier seconded the motion. All were in favor.

# **Proposed Budgets for 2019**

**Library** - Jim Beard, Library Trustee presented the proposed 2019 Library budget. The proposed budget is level funded at \$19,000.

**Cemetery** – Ms. Bjork said that she heard from Ms. Stamatakis, Cemetery Trustee that they will level fund the Cemetery budget at \$4,500 with the exception of a new line item and cost for the mowing and maintenance contractor.

Supervisors of the Checklist – Ms. Bjork said that the Supervisors of the Checklist were not able to submit their proposed 2019 budget this evening but that it would be less than last year due to the number of elections. The Selectmen did receive a request to purchase a new computer with software for the Supervisors of the Checklist. This purchase would be made with money left in their 2018 budget. Selectman Grenier made a motion to allow the Supervisors of the Checklist to purchase a new computer for \$809.95 and another \$100 to erase the election information on the old computer. Chairman Tirrell seconded the motion. Selectman Thurber abstained.

**Conservation Commission** – Mr. Beard presented a proposed 2019 level funded budget of \$5,100 for the Conservation Commission.

## **Highway Department Report**

Mr. Simino discussed two Mill Road culverts that need replacement. Daniels gave an estimate for budgeting purposes. One was for \$425,000 and the other was \$200,000. Mr. Simino explained that DES has different requirements than in the past. Mitchie will also be submitting an estimate. The Selectmen and Mr. Simino discussed the current Bridge repair capital reserve and proposed amount of \$50,000 for the 2019 warrant.

Mr. Simino said that Daniels has been interrupted on the Lovejoy Road project and it may extend until December 15<sup>th</sup>. Mr. Simino said he has changed the signs.

Mr. Simino said that the retaining wall at the Mountain Road Bridge needs to be rebuilt.
