### Agenda Item 1: Payroll and Accounts Payable

The Selectmen reviewed and approved the payroll and accounts payable manifest.

# Agenda Item 2: Minutes of Past Meetings Selectmen's Meeting June 25, 2019

The Selectmen reviewed the draft minutes of the Selectmen's Meeting held on June 25, 2019. Selectman Grenier made a motion to accept the minutes of the June 25, 2019 Selectmen's Meeting as amended. Selectman Thurber seconded the motion. All in favor.

Agenda Item 3: Old Business

Richardson Brook Dry Hydrant – Chairman Tirrell said the project is continuing.

**Long Pond Turn-Around** - Chairman Tirrell said he has met with the property owners and they are waiting on one sibling.

**Mountain Road Speed Limit** – Chairman Tirrell said that we are waiting on the procedural process from Chief Deputy Wilson for changing speed limits but to have for informational purposes only at this time.

Winter Sand – Chairman Tirrell has spoken with Mr. Fulton about extending his offer to purchase winter sand at \$3.50 a cubic yard for 3 years. Mr. Fulton agreed and the Selectmen accepted his offer. Mr. Simino expressed his concern about getting the winter sand during the winter. The Selectmen discussed stock piling some of the sand at the highway department. Moving the sand would be done after the Lovejoy Road culverts.

## **Agenda Item 4: New Business**

#### **Highway Department**

Highway Supervisor Daryl Simino submitted a verbal report this evening.

- The Highway Department has been grading and opening up ditches.
- Mr. Simino has received quotes for paving a section of shoulder on Mountain Road. Selectman Thurber recommended using a sharp corner sign and jersey barriers instead to prevent vehicles riding on the shoulder. The Selectmen agreed.
- Mr. Simino said that he received one quote for crack sealing Mountain Road, waiting on another from the person that does the Town of Washington.

- Mr. Simino discussed the rock sticking up in the road by Stetson's driveway and has spoken with the land owner. They will be working on the water drainage and removing the rock after the Lovejoy Road project.
- 2004 is getting the new dump body. Selectman Grenier offered to drive one of the employees up to Burlington VT to pick up the truck when ready.
- Mr. Simino discussed the Transfer Station having only one employee the next two weeks. Selectman Thurber offered to help out on the 14<sup>th</sup>.
- Mountain Road retaining wall discussed. Selectman Grenier made a motion to hire Daniels Construction to do the project. Selectman Thurber seconded the motion. All were in favor. Money to come out of CIP 048 Road Repair and Reconstruction.

Chairman Tirrell and Mr. Simino discussed the beaver situation on Lovejoy Road. Chairman Tirrell said that Jon Thomas removed 3 beavers and broke up the dam. The water level has receded at this time. Mr. Simino will continue to work with Fred Greenwood as needed for beaver removal.
